## Instructions:

- 1) Applicant must be at least 18 years of age.
- 2) Applicant must provide copy of their Connecticut Sales Tax Permit and copy of Health Certificate if selling food items.
- 3) Applicant must provide copy CT Driver's License or acceptable proof of identification.
- 4) An application must be completed for each vendor/solicitor/peddler.
- 5) A background check will be done on each applicant. Once completed, the applicant will be notified if the permit has been approved or denied.
- 6) The permit fee of \$25.00 for each applicant must be paid by bank check or money order (payable to East Windsor Police Department)
- 7) Permits are nontransferable and are valid for only the dates requested on the application (up to one year).
- 8) Every vendor/solicitor/peddler must notify Dispatcher of location, vehicle information (if changed) and times they will be in the community each day.
